

## **Notification of appeal**

# From Disciplinary Tribunal Final Decision By-Law 40.22(a)

#### Instructions

Please complete **all sections (1–5)** and return the form to Chartered Accountants Australia and New Zealand (CA ANZ) (see **page 4** for contact details).

#### Matters to consider before completing the form

- 1. An appeal must be lodged within 21 days, or such longer timeframe as approved by the Appeals Council in its discretion, after the date of written notification of the Final Decision of the Disciplinary Tribunal.
- 2. Only the Member or Notifying Principal on behalf of a Practice Entity or the Professional Conduct Committee may appeal a decision of the Disciplinary Tribunal.
- 3. A notice of appeal must be submitted on this prescribed form and state the grounds of appeal in full. The notice of appeal and the grounds of appeal cannot be amended except with the approval of the Appeals Council.
- 4. The appellant must also give notice of any Final Decision of the Disciplinary Tribunal that it seeks be stayed pending determination of the appeal.
- 5. The Appeals Council may, at its discretion or on an application by the Professional Conduct Committee:
  - require the Member or Notifying Principal on behalf of a Practice Entity to pay such amount as it determines to CA ANZ as security against the anticipated Costs which CA ANZ may incur in the conduct and hearing of the appeal.
  - stipulate a time period of not less than 28 days within which the Member or Notifying Principal on behalf of a Practice Entity must pay the security amount and, if it does so and the Member or Notifying Principal on behalf of a Practice Entity has not paid that amount at the expiry of that period, the appeal will automatically lapse.
