

Collection Statement

This Collection Statement contains details about how Chartered Accountants Australia and New Zealand ABN 50 084 642 571, including its subsidiaries and the New Zealand Institute of Chartered Accountants, a regulated body established under the *Institute of Chartered Accountants Act 1996* (NZ), (together, **CA ANZ**) may collect, hold, use and disclose personal information about you in relation to your participation of surveys and use of services offered by Profiling Online (**Profiling Online**).

With your consent, CA ANZ will disclose your name and email address (as recorded in CA ANZ's database) to Profiling Online to facilitate your access to Profiling Online through CA ANZ. If you choose not to give this consent, CA ANZ will not be able to facilitate such access.

We are permitted to process your information for the above purpose, by relying on one or more of the following lawful grounds: (a) you have explicitly agreed to us processing such information for a specific reason; (b) the processing is necessary to perform the agreement we have with you or to take steps to enter into an agreement with you; (c) the processing is necessary for us to comply with our legal obligations; or (d) the processing is necessary for our legitimate interests, which include: (i) collecting personal information to provide you with a smooth and efficient customer experience; (ii) to evaluate, develop or improve our products and services; (iii) to keep you informed of relevant products and services unless you indicate that you do not wish us to do so; (iv) to prevent fraud.

Where you have consented to our processing of such information, you may withdraw such consent at any time, by contacting us using the contact details in our [Privacy Policy](#). Please note, however, that in certain circumstances it may be still lawful for us to continue processing this information even where consent has been withdrawn, if one of the other legal bases described above is applicable.

While your personal information is collected by CA ANZ in Australia, it is likely that your personal information will be disclosed to overseas recipients in accordance with our [Privacy Policy](#).
