CASM Terms and Conditions

Chartered Accountants Australia and New Zealand - CA Study Masterclass

1. Registration for the Chartered Accountants Study Masterclass ("CASM") is deemed acceptance of these Terms and Conditions ("Terms").
2. A provisional member may cancel their CASM registration, however there is no option to defer, provide credit or transfer registration to another provisional member. Upon a cancellation, the refund amount is dependent on the notification period and circumstances resulting in cancellation.
Full refund of the CASM fee in the following circumstances:
 - You will be eligible for a full refund upon notification to CAANZ of your discontinuation prior to the relevant CA Program module commencement date. Once discontinued from the program, please place your refund request in writing and forward to casm@charteredaccountantsanz.com.
 - If you are part of a bulk enrolment, you will be eligible for a full refund upon notification to CAANZ of your discontinuation via your CA Program coordinator prior to the relevant CA Program module commencement date.**Refund of 70% of CASM fee** in the following circumstances:
 - You will be eligible for a refund of 70% of the CASM fee upon notification to CAANZ of your cancellation within three weeks of the relevant CA Program module commencement date.
