ACA / CA Provisional Membership

The academic requirements for becoming a Chartered Accountant or Associate Chartered Accountant are the same. Students intending to become Chartered Accountants or Associate Chartered Accountants must complete the following academic requirements:

1. Completion of a New Zealand or Australian bachelor's degree or a qualification that is assessed as comparable
2. Required competence areas. Students must complete specific subjects to cover the competence areas.

IMPORTANT NOTES

Commercial and Corporate Law

To satisfy the Commercial and Corporate Law topic in full, students must complete the specific subjects outlined in this Accredited Tertiary Course List (ATC). If the Commercial and Corporate Law competence area has been partially completed at another tertiary students will need to approach their new tertiary to discuss the possibility of obtaining specified cross credits towards the required subjects. If the tertiary is not able to award cross credits the student will need to complete the relevant subject's outlined in this document to satisfy the Commercial and Corporate Law competence area in full.

MPA/MPAF/MPAcct Graduates

If you have completed and been granted one of Chartered Accountants ANZ's approved MPA/ MPAF/ MPAcct qualifications including all the approved subjects outlined for this course at a Chartered Accountants Australia and New Zealand approved tertiary, you will not be required to provide evidence of a Bachelor's degree when applying for Provisional Membership.
