

PI insurance policies

for small practices in Australia (November 2019)

As a member of Chartered Accountants Australia and New Zealand (CA ANZ) you should have professional indemnity (PI) insurance to protect your business, to comply with Regulations and, if you are a holder of a Certificate of Public Practice (CPP), Affiliate member or Practice Entity member resident in Australia, it is a requirement under the Professional Standards Scheme (Scheme).¹

The amount of PI insurance required under the current Scheme and Regulation CR2A depends on the size of your business and the nature of the services you provide. Our website contains more information about the Scheme and a link to Regulation CR2A.

Not all policies available suit small practices, or those offering a limited range of services. This summary provides details provided to us by various PI insurance brokers.
