### Note 1 – Reporting entity

7.5 NZ SME Agriculture Entity is a privately owned sheep and dairy farm.

These financial statements have been prepared on a historical cost basis, except for certain assets which have been revalued as identified in specific accounting policies below. The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$, except when otherwise indicated.

8.22 **Changes in accounting policy**

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous period.

**5.11 Exceptional items**

Exceptional items are large income and/or expense items that do not arise as a result of normal business operations and are not expected to recur. Exceptional items are disclosed separately in the statement of profit or loss where the total value exceeds 5% of revenue.

**23.13 Business combinations**

Business combinations, excluding the acquisition of an equity interest, are accounted for using the purchase method. The cost of a business combination is an aggregate of the fair value of assets purchased, liabilities assumed or incurred and any equity issued in exchange for consideration received.

**9.32 Revenue recognition**

Revenue is measured at the fair value of the consideration received or receivable for the sale of goods and services, to the extent it is probable that the economic benefits will flow to the company and revenue can be reliably measured.

Sales of services are recognised in the period by reference to the stage of completion of the transaction at the end of the reporting period.

Sales of goods and livestock are recognised when the entity has transferred the significant risk and rewards associated with ownership of the goods to the customer.

Forestry income is recognised on sale or harvest of the forest.

Lease income is recognised on a straight line basis over the life of the lease.

Interest received is recognised as interest accrues, gross of refundable tax credits received.

Dividends received are recognised on receipt, net (or gross) of non-refundable tax credits.

*either*

Government grants are recognised as revenue on receipt where no performance conditions have been specified on receipt of the grant.

*or*

Government grants requiring specified future conditions to be performed are recognised as a

liability on receipt. The grants are recognised as income over the period that the specified conditions are complete and the associated costs are recognised.

12.12/ **Agricultural produce**

12.32 Agricultural produce, such as wool and other products, is recognised on separation or harvest and is stated at the lower of cost, determined on a first-in-first-out basis, and net realisable value as valued under the Income Tax Act 2007.

Cost includes the cost of direct materials, direct labour and a proportion of fixed and variable production overhead expended in putting agricultural produce in its present location and condition.

15.43 **Accounts receivable**

Accounts receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less an allowance for any uncollectible amounts. Individual debts that are known to be uncollectable are written off in the period that they are identified.

20.14/ **Foreign currencies**

20.15 Transactions in foreign currencies are converted at the New Zealand rate of exchange ruling at the date of the transaction. At balance date foreign monetary assets and liabilities are translated at the closing rate and variations arising from these transactions are included in the statement of profit or loss.

**Alternate**

*Transactions in foreign currencies are converted at the New Zealand rate of exchange ruling at the date of settlement. At balance date outstanding foreign monetary assets and liabilities are translated at the closing rate and variations arising from these transactions are included in the statement of profit or loss.*

12.10/ **Livestock**

12.32 Either: a) *Held at fair value, not at rates permitted by Income Tax Act 2007*

Livestock is measured at fair value less cost to sell. Holding gains and losses are recognised in the livestock revaluation reserve. If the revaluation reserve has a deficit for a unit or group of livestock, that deficit is recognised in profit or loss in the period that it arises.

Or: b) *Held at fair value, rates permitted by Income Tax Act 2007, i.e. Herd Scheme*

Livestock is measured at national average market values as issued by Inland Revenue as a proxy for fair value less cost to sell. Holding gains and losses are recognised in the livestock revaluation reserve. If the revaluation reserve has a deficit for a unit or group of livestock, that deficit is recognised in profit or loss in the period that it arises.

Or: c) *Cost using one of the methods permitted by the Income Tax Act 2007, i.e. National Standard Cost*

Livestock is measured at national average production costs as issued by Inland Revenue as a proxy for cost of production. Movement in the valuation of livestock is recorded in profit or loss in the year incurred.

If applicable:

*Income equalisation deposit scheme [applicable to eligible entities – farming, fishing, forestry]*  
As permitted by the Income Tax Act 2007, deposits and withdrawals to the income equalisation deposit scheme, to assist with income equalisation, are recorded in profit or loss in the year of deposit or withdrawal.

12.10/ **Forestry**

12.32 Either: *a) Held at fair value, not at rates permitted by Income Tax Act 2007*

Forestry is measured at fair value less estimated costs to sell as assessed by independent forest managers. The basis of valuation of young stands not yet ready for harvest has been to determine the net present value of each stand. The revenue from future timber sales is predicted along with the costs of producing, harvesting and marketing the timber. The pre-tax cash flow is discounted at the appropriate market rate to derive a net present value.

Revaluation gains and losses are recognised in the forestry revaluation reserve. If the revaluation reserve has a deficit, that deficit is recognised in profit or loss in the period in which it arises.

Or: *b) Held at cost, as permitted by Income Tax Act 2007*

Forestry assets are measured in accordance with treatment permitted by the Income Tax Act 2007. The purchase of established forests is recorded at cost and recognised in profit or loss on sale or harvest of the forest. Subsequent expenditure for planting and growing is recorded in profit or loss as incurred.

If applicable:

*Income equalisation deposit scheme [applicable to eligible entities – farming, fishing, forestry]*  
As permitted by the Income Tax Act 2007, deposits and withdrawals to the income equalisation deposit scheme to assist with income equalisation are recorded in profit or loss in the year of deposit or withdrawal.

11.47 **Property, plant and equipment and investment property**

11.48 Property, plant and equipment and investment property are stated at historical cost less any accumulated depreciation and impairment losses. Historical cost includes expenditure directly attributable to the acquisition of assets, and includes the cost of replacements that are eligible for capitalisation when these are incurred.

11.35 – **Alternate – Revaluation option – property plant and equipment**

11.39 *Freehold land and buildings are revalued on a cyclical basis every three years to fair value, as determined by an independent valuer. Revaluation gains are transferred to the asset revaluation reserve for that class of assets. If any revaluation reserve has a deficit, that deficit is recognised in profit or loss in the period it arises. Any revaluation surplus that reverses previous revaluation deficits in subsequent periods is recognised as revenue in profit or loss.*

11.49 **Alternate - Revaluation option – investment property**

*Investment property is revalued to fair value on a cyclical basis every three years as determined by an independent valuer. Revaluation gains are recognised in profit or loss in the year of valuation.*

11.48 *[disclosed either in accounting policies/property, plant and equipment note or in property, plant and equipment register if separately attached]*

Depreciation is calculated on a straight line/diminishing value basis over the estimated useful life of the asset *either* using depreciation rates published by Inland Revenue *or* based on estimates by management. Assets' estimated useful life is reassessed annually. The following estimated depreciation rates/useful lives have been used:

All other repairs and maintenance expenditure is recognised in profit or loss as incurred.

11.42 An item of property, plant and equipment or investment property is derecognised upon disposal or  
11.43 when no further future economic benefits are expected from its use or disposal. Any gain or loss  
11.45 arising on derecognition of the asset (calculated as the difference between the net disposal proceeds  
and the carrying amount of the asset) is included in profit or loss in the year the asset is derecognised.

11.44 **Alternate – Revaluation option – property, plant and equipment only**

*Upon derecognition, the asset revaluation reserve relating to the asset disposed shall be transferred to retained earnings.*

**Intangible assets**

13 Intangible assets are carried at cost less any accumulated amortisation and any accumulated impairment losses. Internally generated intangible assets, excluding capitalised development costs, are not capitalised and expenditure is recognised in profit or loss in the year in which the expenditure is incurred.

13.15 **Internally generated intangibles – Research and development**

13.17 Research costs are expensed as incurred. Development expenditure on an individual project is  
13.20 recognised as an intangible asset when the Company can demonstrate: the technical feasibility of completing so it will be available for use or sale; the intention to complete and its ability to use or sell the asset; how the asset will generate future economic benefits; availability of resources to complete the asset; and the ability to reliably measure expenditure during development.

13.22 Intangible assets are amortised on a systematic basis over their useful life and tested for impairment  
13.25 – whenever there is an indication that the intangible asset may be impaired. The amortisation period  
13.29 and the method for an intangible asset is reviewed at each financial year-end. Changes in the expected useful life are accounted for by changing the amortisation period for the current and future reporting years. Where no reliable estimate can be determined, the intangible asset will be amortised over 10 years.

The following estimated amortisation rates/useful lives have been used:

Customer contracts	x	years straight line

13.33 Gains or losses arising from derecognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in profit or loss when the asset is derecognised.

23.25 **Goodwill**

Goodwill is an intangible asset representing the future economic benefits arising from assets acquired in a business combination that are not individually identified and separately recognised.

23.7 – Goodwill is measured at cost less any accumulated impairment losses. Cost is the excess of  
23.8 consideration paid over the acquirer’s interest in the net fair value of identifiable assets of the acquired business at the date of acquisition. Goodwill is assessed for impairment at least annually.

16.8 **Impairment of non-financial assets**

16.13 At each balance date, non-financial assets are classified into four categories: assets measured at fair value; assets currently available that the company intends to use to the end of its useful life; assets intended to be sold prior to the end of their useful life; and assets damaged or idle at balance date.

Assets measured at fair value, or assets the company intends to use to the end of its useful life, are not reviewed for impairment at balance date.

Assets intended to be sold prior to the end of their useful life, or assets damaged or idle at balance date, are reviewed to determine if any indicators of impairment exist. If indicators exist the asset is tested for impairment to ensure that the carrying amount of the asset is recoverable.

If the recoverable amount of an asset is determined to exceed its carrying amount then the resulting difference is recognised as an impairment loss in profit or loss for that period.

14.9 **Joint ventures**

14.11 The company has an interest in joint venture operations, where the company is entitled to a share of  
14.13 future economic benefits and is exposed to the related risks, for activities jointly controlled by multiple participants. The company's interest is recorded using the proportionate method, where the company recognises its share, in the respective categories of:

- Assets employed;
- Liabilities incurred;
- Revenues earned and expenditure incurred (including movements in fair value, impairments recorded and gains/(losses) on derecognition of assets.

**Financial instruments – financial assets**

15.10 At initial recognition the company determines the classification of financial assets as either held at  
15.14 fair value, cost or amortised cost. Financial assets are measured initially at fair value, estimated at the transaction price less any associated transaction costs.

15.20 *Amortised cost*

15.29 Includes assets where the company intends to earn contractual cash flows in the nature of principal and interest payments. Such assets are carried at amortised cost using the effective interest method. Gains and losses are recognised in profit or loss when the assets are derecognised or impaired, as well as through the amortisation process.

15.34 *Cost*

Equity instruments are classified as held at cost. Assets are stated at cost less any accumulated impairment loss. Gains and losses are recognised in profit or loss when the assets are derecognised or impaired.

15.31 *Fair value*
